 The friend appointed in affair of Abigail Parson by her Certificate reports they find nothing sufficient to hinder it therefore she is ordered to give her own Sarah Thurmer & Ann Aukton for again appointed to attend the next Quarterly meeting.

 from George Cook appeared Susanna Hurston from Little Creek Susanna Hanson & Eliza Jenkins  
 The friends appointed to oversee the marriage of Thomas Brown & Ellen Cogill report that it was performed with Decency and Orderly  
 The further publication of the marriage of William Farson & Rachel Udal is deferred until our next meeting, her Certificate being not yet come to hand from Woodbridge  
 The friends appointed to attend the last Quarterly meeting report they were there.
